This will be a closed meeting which will report back to the Parish Council</p> <p>Three meetings have been held with Newburgh re the proposed development of Bumper Castle. If the Estate is willing to consider this Highways approval will need to be sought as well as planning permission from NYMNPA.</p> <p>The deeds of the car park were passed to Cllr. Rheinberg for information.</p> <p>Currently we are 8-10 parking spaces short in the existing car park</p> <p>Resurfacing; - Acting Clerk Wyn-Jones reported back that Kilburn Parish Council have had the area by the Foresters Arms / Church resurfaced with tarmac at a cost of £25k</p>	<p>SR</p>

5.Tree felling and planting; grass cutting and hedge cutting; dog fouling and rubbish bins.	<p>It has come to the attention of the PC that there have been breaches of regulations and the law with respect to tree felling in private gardens in the conservation area of the village, and with dog fouling particularly along the railway walk.</p> <p>A circular reminding residents of their responsibility with respect to these issues will be sent out with the next village newsletter.</p> <p>A notice<0.4sq. metres to be erected at the end of the Railway walk reminding dog walkers of their responsibility.</p> <p>It was agreed to plant trees by the Beck in the playing fields area, up to £200 from the budget of the planting group will be set aside for this purpose.</p> <p>The cost of grass cutting to residents was discussed.
